WAIVER AND RELEASE FROM ALL CLAIMS

I consent to the use of a jump harness in the teaching of me/my child's ice skating routines. I have inspected the jump harness and the related apparatus. I understand the belt will be attached to me/my child's waist in order to enable a skating instructor to lift me/my child three to five feet off the ice surface, to be pulled along, and then lifted during the jump. The rope/pulley, which is part of the apparatus, is attached to a wire that is stretched over the ice surface.

I consider of my participation of any Winterhurst Figure Skating Club (WFSC) program or Basic Skills activity, I acknowledge that I understand the nature of the activity and that I, and/or my minor child, am qualified, in good health, and in proper physical condition to participate in such activity. I acknowledge that if conditions are unsafe, I and/or my minor child will immediately discontinue participation in the activity.

I fully understand that skating involves risks of serious bodily injury, including, but not limited to, permanent disability, paralysis, and death, and that these and other risks may be caused by my own actions or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of releases named below. I fully understand that there may be other risks either not known to me or not foreseen at this time, and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity.

I hereby release, discharge, and covenant not to sue WFSC, its respective administrators, directors, agents, officers, volunteers, and employees, and any sponsors and advertisers of any WFSC event in which I participate (each considered one of the Releasees herein) from all liability, claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the Releasees. This release waiver of liability and express assumption of risk agreement does not apply to any liability, claims, demands, losses, or damages arising out of gross negligence of, or intentional, willful or wanton misconduct of Releasees. If I, or anyone in my and/or my minor child's behalf, makes a claim which does not arise from gross negligence of, or intentional, willful or wanton misconduct of Releasees against any of the Releasees, I will indemnify, defend, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which may incur as a result of such claim.

I acknowledge that I have read this release, waiver of liability and express assumption of risk agreement and fully understand it.
