Description of Categories:

First Family = home club members.

If you are on the board, the club will pay for your first family membership in appreciation for your service.

Subsequent First Family is for additional members in the same family living in the same [household ie](#) sibling, parents.

Senior Membership (65 and Up) Same benefits as Home Club members but at discounted price for our seniors.

First year Introductory- this is only for first time members of any USFS club- does not apply to changing to a new club. Useful for prior LTS members who want to join a club for the first time. Same benefits as home club members.

2nd year introductory- We offer an additional discounted year after the first introductory year. Same benefits as Home club members

Associate membership- USFS fees have already been paid by their home club. See benefits below.

Home club Coaches- The USFS membership fee went up to \$77.00. We will just charge the USFS fee for our Home Club coaches. Benefits are the same as Home club members and they have priority on the ice.

Associate Coaches- We don't charge membership fees to associate coaches- their USFS membership fee has already been paid by their home club.

Collegiate- this is a 4 year membership for members attending college. It is a one time opportunity.

Officials- these include: judges, accountants, announcers and delegates

Transfer- No charge for transferring from another USFS member Club since USFS dues have already been paid.
